GENERAL INFORMATION AND TOUR CONDITIONS

Reservations and Payments:

A deposit of \$1,000 per person is required at the time of registration. Final payment is to be made 90 days prior to departure. The deposit of \$1,000 per person, made out to "Garden Adventures, Ltd.," is required at the time of registration, and is subject to the terms below. Final pricing will be established 100 days prior to departure. Final payment is to be made 90 days prior to departure. Please note that a \$1,000 donation per person to the Morris Arboretum is a non-refundable charitable donation, and also required at the time of registration.

Cancellation and refund policy – cancellation fees are as follows:

Up to 90 days prior to departure: \$500.00

No refunds will be given on cancellations less than 90 days prior to departure.

Trip cancellation insurance is highly recommended.

Passports:

Tour participants must be in possession of a passport that is valid six months from the date of departure. U.S. Citizens are required to have a Visa for travel to New Zealand.

Responsibilities:

Garden Adventures, Ltd. (GAL) acts only as agent for the passenger with respect to all transportation, hotels, and all matters of reservations and tour operations. Services in connection with this itinerary are rendered by suppliers acting as independent contractors and not as agents or employees of GAL. In accepting these services you agree that GAL will not be liable for any acts, errors, omissions, negligence or default of an independent contractor or their employees or agents for injury, damage, death, loss, accident, inconvenience or delay in person or property.

Baggage is carried at the owner's risk.
3. All accommodations, services and facilities are subject to the law and customs of the countries in which they are rendered. We reserve the right to substitute services, features and hotels of similar quality without notice.

GAL reserves the right to cancel or withdraw any and all tours should it become necessary for the comfort and well-being of tour participants or for any reason whatsoever and shall have no responsibility or liability due to such cancellations or alterations. Should the tour be canceled in its entirety, GAL shall refund all deposits and monies paid by our participants. GAL is not responsible for any loss incurred on account of non-refundable or unrecovered costs.
5. GAL reserves the right to decline to accept or retain any tour participant at any time, and in such event, shall have no liability to such persons except to refund amounts as our absolute discretion deems reasonable to attribute to the uncompleted portion of the tour.

Acceptance of the services of GAL and any payment by an individual tour participant constitutes agreement by tour participants with all the above noted terms and conditions.
